**ORDINANCE  
OF THE MINISTER OF INFRASTRUCTURE<sup>1)</sup>**

of August 7, 2023

**on the confirmation form of posting a driver to the territory of the Republic of Poland from a third  
country**

Based on Article. 12 sec. 7 of the Act of 28 July 2023 on the posting of drivers in road transport (Journal of Laws pos. 1523) it is ordered as follows:

§ 1. Specifies the form of confirmation of the posting of the driver on the territory of the Republic of Poland from the state third, constituting an annex to the regulation.

§ 2. The regulation enters into force on August 19, 2023.
